YEAR 1 LEAD PREVENTION ORGANIZATON REGION 1 ANNUAL REPORT

Activities & Outputs & Feedback covering the period of July 2023 – June 2024

United Way of Northwest Vermont is the Lead Prevention Organization (LPO) for the Vermont Department of Health, Division of Substance Use programs (DSU), serving Region 1: Barre, Burlington, & St. Albans Health Districts. DSU is providing new prevention funding to four regions across the state, through partnership with a Lead Prevention Organization in each region. The purpose of this funding is to increase state, regional, and community capacity to deliver meaningful substance misuse prevention statewide, by addressing all ages and substances, ensuring access, decreasing disparities, and developing a consolidated and holistic approach.

Previous grants from DSU supported the development of a 5-year strategic plan and a Regional Prevention Network for Northwest Vermont. Starting in July 2023, DSU expanded the region to include the Barre Health District and now United Way acts as the LPO for Northwest and Central VT.

Major goals for Year 1 included:

- 1. Expanding regional focus to include Central Vermont.
- 2. Expanding the scope of prevention strategies to all ages.
- 3. Establishing a new funding process for allocation of state funds, including convening a regional Funding Committee to determine a portfolio of grants starting January 2024.
- 4. Investing capacity building funds to strengthen existing prevention efforts, fill gaps, and develop tools and resources to engage a broader range of partners and communities.

The purpose of this Annual Report is to provide a summary of activities and achievements during Year 1 of the LPO grant to the Northwest & Central VT region. Building Partnership with Central Vermont

A priority for Year 1 was expanding the region to include Central VT and building connections to partners in the Barre Health District. United Way contracted with Eva Zaret from Central VT Medical Center & Sultana Khan from Mosaic; they informed and led LPO activities in the Barre Health District, including: completing and inventory of organizations doing prevention work, convening a Prevention Summit at which community partners came together to review data, have robust conversations, and determine priorities, recruiting partners and community members to serve on the Funding Committee, and helping facilitate the committee's process.

Through partnership with CVMC and Mosaic, we learned more about the capacity and accomplishments of Central VT Prevention Coalition, and we explored ways the LPO and a Regional Prevention Network can add value to their work.

Evaluation of the LPO and the Regional Prevention Network

LPO staff worked with consultants from *Pear Associates* to **develop a comprehensive evaluation plan** for the Prevention Network and our role as the LPO.

The consultants conducted a **focus group with local prevention partners** to gather input on how to define and evaluate success and how to gather data to assess success and make improvements. They also met with LPO/Prevention Network funders (DSU and UVM Medical Center's Community Health Improvement Committee) to understand the funders' goals and expectations. The consultants completed the Evaluation Plan in spring 2024; the plan was shared with regional partners and funders. Evaluation activities will launch in Fall 2024.

Evaluation activities in Year 1 included:

- survey of everyone who received the fall 2023 Request for Proposals for allocation of state funds; the survey asked about accessibility and clarity of our communications about and process for applying for subgrant funds,
- in-person debrief and follow up survey with Funding Committee members to get input on the Year 1 process and recommendations for improvement in Year 2.
- Survey of network partners to gather feedback and suggestions for Prevention Network meetings, newsletters, website, and trainings.

As the LPO, United Way secured the additional resources to advance prevention in Northwest and Central VT:

- Partnership with VT National Guard Counter Drug Program, which provides a full-time position to lead the Prevention Network
- \$100,000 Collective Impact Implementation Grant from UVM Medical Center Community Health Investment Fund
- Intern from University of Vermont focused on Healthy Aging & Substance Use in VT
- AmeriCorps VISTA Position from SerVermont

Investing in Prevention Coalitions

The purpose of the planning process was to support coalitions in identifying how the coalitions can work together, share expertise and resources, and create a more sustainable and efficient prevention strategy.

Engaging Employers in Substance Misuse Prevention

Project: Creating an employer guide focused on substance misuse prevention and recovery, in collaboration with United Way's Working Bridges program and Prevention Works!VT as part of a workgroup of partners representing employers as well as community organizations.

Purpose:

- Providing information, guidance, resources for VT businesses whose employees and workplaces have been directly impacted by substance misuse.
- Informing policies, practices, and culture to create safe and supportive workplaces and addressing employees' needs related to substance misuse, treatment, and recovery.
- Collaborating with employers to prevent substance misuse and related impacts.

The employer guide will be completed and shared widely in Fall 2024.



GRANT COMPLIANCE & ACCOUNTABILITY

Responsibilities of the Lead Prevention Organization

As the Lead Prevention Organization and fiscal agent for state prevention funds, United Way is responsible for grant compliance and accountability to the Division of Substance Use program (DSU). Requirements include:

- creating an annual budget and detailed workplan,
- establishing and facilitating a Regional Funding Committee and subgrant process,
- DSU approval of subgrant portfolio,
- quarterly reporting on activities and workplan process,
- quarterly invoicing to DSU for all grant expenses, including quarterly reporting from subgrantees,
- annual site visit and review of financial documentation,
- monthly meetings with DSU,
- monthly meeting with the other Lead Prevention Organization teams in VT,

We are also accountable to the Community Health Investment Committee, through annual reporting, and to the VT National Guard's Counter Drug Program, which provides in-kind support through a full-time position.

And we strive to be accountable to all of our prevention partners through inviting input and feedback, providing regular updates through network meetings and communications, and being transparent and collaborative in our planning, processes, and decisions.

OUTSTANDING GOALS & ACTIVITIES

Work planned for Year 1, but not completed

We did not make as much progress as we had hoped in several areas of planned work, due to the extent of effort and capacity required to complete the work outlined in this report, and in some cases due to stage of readiness or capacity among key partners Areas of work that we did not complete in Year 1 include:

- establishing a governance structure for the Prevention Network, to support committees and action teams, and facilitate decision-making,
- engaging other funders in our region to share prevention-priorities and progress, discuss process and opportunities for leveraging funds, and explore collaboration,
- developing tools and practices for collaborative advocacy.

These activities continue to be priorities for our work in Year 2.
